REQUEST FOR PROPOSALS

General Counsel Legal Services Contract January 1, 2026 – December 31, 2030

The Housing Authority of the Town of Manchester (hereinafter referred to as the "Authority", "MHA", or the "Housing Authority") herein requests proposals for legal services including the following:

- 1. General Counsel
- 2. Special Counsel for Housing Litigation matters and Rent Collection
- 3. Labor Matters
- 4. Development / Repositioning/Construction/Real Estate

Proposals are invited from individual lawyers or legal firms (hereinafter referred to as "general counsel", "special counsel", "Labor Matters", or "Development / Repositioning/Construction/Real Estate" "respondent", or "Offeror") that will comply with all requirements of applicable statutes, regulations, policies and organizational objectives of the MHA.

Bidders must have experience in the provision of relevant legal services and be a member of the Connecticut Bar. The General Counsel must have experience involving housing (development and management), governmental entities and regulations, contracts, permanent and temporary note financing, ex contract and ex delicto actions, litigation, real property laws and codes, human services arbitrations, Connecticut housing law and programs, and Federal housing law and programs.

This Request for Proposals (RFP) contains specific submission requirements, general scope of service requirements, and terms, conditions, and other pertinent information necessary for submitting a proposal. Interested parties may obtain the Request for Proposal package in person beginning *October 6, 2025*, Monday through Friday, between the hours of 8:00 AM and 4:00 PM, at 24 Bluefield Drive, Manchester, CT. 06040; by telephone request using 860-643-2163 ext. 101; or by mail or visit the MHA website at www.manchesterha.org.

MHA Mission, Description, Logistics

The Housing Authority of the Town of Manchester:

- Established to provide safe, decent, sanitary, and affordable housing to low-income families without discrimination.
- MHA owns and operates a variation of public housing developments and programs consisting of (1) 535 Federal Section 8 Housing Choice Vouchers; (2) 1900 DSS-SERT vouchers for the State of CT thru a contract with J.A. D'Amelia & Associates; (3) 243 units of Federal Low-Income Public Housing; (4) 48 units under a RAD Transaction; (5) 80 units of State Low-Income Public Housing (LIHTC); (6) 37 State of Connecticut Congregate Housing.
- It is governed by a 5-member board of commissioners. Four members are appointed by the Board of Directors, and a Resident Commissioner is selected pursuant to the procedures found at CGS 8-41.
- The MHA has formed a Non-Profit Manchester Housing Corporation (MHC) instrumentality for strategic planning and future development of low-income housing. An annual 990 tax return must be completed and submitted for this entity.
- Has a staff of 23 full-time. Six employees work in the maintenance department. The remaining employees work in the main office. Non-Union
- Process of a RAD Conversion with its Federal Developments

The Manchester Housing Authority's fiscal year runs from October 1st through September 30th.

REQUEST FOR PROPOSALS FOR GENERAL COUNSEL LEGAL SERVICES

The scope of services for which MHA is soliciting proposals is generally to provide comprehensive legal services as General Counsel Legal Services to the Manchester Housing Authority. The examples of services shall include, but is not limited to the following:

- 1. To act as Attorney for the authority in all matters for which the authority may request legal counsel.
- 2. To represent the authority in all general litigation matters, both as plaintiff's counsel and defendant's counsel.
- 3. Review of BOC meeting agendas and legal supervision of the official minutes; compliance with the Connecticut Open Meeting Law; governance requirements contained in the relevant Code of Federal Regulations (CFR), HA policies and procedures and By-laws and actions that will put the MHA at risk for liability exposure.
- 4. Be available to attend regular and special meetings of MHA, if requested by the Executive Director or the Board of Commissioners, where legal advice is likely to be needed.
- 5. To be available for consultation, upon reasonable notice, with the Executive Director, Staff, and the Commissioners.
- 6. To inform the Executive Director, Staff, and the Commissioners, on a continuing basis, of their rights and duties regarding current statutes and court decisions.
- 7. To inform the Executive Director, Staff, and the Commissioners, on a continuing basis, of their rights and duties regarding rules and regulations by US Department of Housing and Urban Development (HUD), the CT Department of Housing (DOH), and CT Housing Finance Authority (CHFA), when applicable.
- 8. To review contracts and bidding documents requisite to the construction or rehabilitation of new or existing housing developments.
- 9. To review the legality of all contracts to which the Authority is a party and advise the Authority on request regarding disputes arising under such contracts.
- 10. To prepare legal and other documents required in the course of Authority business.
- 11. To represent and advise members of the Authority Board of Commissioners and Authority staff, acting in their official capacity.
- 12. To attend conferences and/or hearings regarding Authority business with HUD, DOH, CHFA or its representatives upon invitation, or with other private or public agencies.
- 13. To give advice regarding, and represent the Authority in actions by or against the Authority before a Court, DOH, CHFA, HUD and other agencies
- 14. To give advice regarding and represent the Authority in actions by or against the Authority before CT Commission on Human Rights and Opportunities (CHRO).
- 15. Advise and assist with civil rights and fair housing requirements, including claims involving violations of the Civil Rights Act of 1964, the Rehabilitation Act of 1973 and the Americans with Disabilities Act (ADA).
- 16. Represent the Authority in summary process actions for non-payment of rent.
- 17. Represent the Authority in summary process actions for nuisance.
- 18. Assist in the enforcement of Authority's leases, rules and regulations, if any, with letters, calls, or other appropriate action at the request of the MHA.
- 19. Perform legal services in connection with land acquisition for new developments or project improvements, including title searches and preparing deeds, securing exceptions and/or variances from zoning and building ordinances, applying for zoning alternatives, and carrying out eminent domain proceedings where necessary.
- 20. To provide Legal Services for affiliate non-profit corporations at the request of the Executive Director.
- 21. To render other legal services normally required in the conduct of Authority business.

Please note that the preceding is not intended to be an all-inclusive listing of all of the legal issues that the MHA may retain the successful proposer to provide, rather it is intended to be a representative listing of issues for which the MHA has previously required legal services.

Presently MHA has legal counsels provide periodic guidance and advice on regulatory and statutory changes that affect its operations. Additionally, MHA has its counsel to review the leases, lease addendums, Notice To Quit and KAPA notices on an annual or as needed basis to ensure technical compliance and relevance. MHA has produced and issued the

required notice to quits for non-payment issues only or KAPA notices for minor violations internally and coordinates the marshal for delivery of such notices as required.

MHA issues an average of 10 notice to quits each month and perhaps 5 of those require MHA to issue counsel for counsel to file the required paperwork for entry into court and represent the MHA.

As a business course MHA enters contracts or MOUs for services and requires counsel to review the contracts on behalf of the MHA. The frequency would typically be less than ten instances per year but in certain years it could be greater.

REQUEST FOR PROPOSALS FOR LABOR MATTERS

The MHA is seeking proposals from qualified licensed, experienced, insured and bonded entities to provide a range of labor-related legal services. These services are a necessary supplement to the daily operation of the MHA. The successful proposer shall be the legal advisor to the MHA Board of Commissioners (BOC) and the MHA Executive Director (ED) on labor-related issues. Services may include, but are not limited to the following

- 1. Review of current job descriptions and new responsibilities.
- 2. Creation of new job descriptions,
- 3. Review and assist in the implementation of The Agency Personnel Policy,
- 4. Assist in the development of the MHA Employee Training Schedules and Procedures.
- 5. If the successful proposer does not have in-house a qualified person to provide any services required by the MHA, the successful proposer may retain another counsel who has such a qualified person. Such retention must have prior written approval of the MHA. Any billing/payment for such additional counsel will be at the same hourly rate listed within the contract (meaning, the successful proposer may not add an additional amount to the contracted hourly fee for retaining and overseeing such additional counsel). As the MHA will contract with the successful proposer only, all ensuing payments for any contracted matter will be made by the MHA to the successful proposer only.
- 6. The MHA reserves the right to, at any time during the ensuing contract period, and without penalty to the legal counsel retained as a result of this RFP, conduct additional competitive solicitations to retain additional legal counsel when, in the opinion of the ED, it is in the best interests of the MHA to do so. Accordingly, the legal counsel retained as a result of this RFP shall have the right to also respond to any such additional solicitation process, if conducted.

REQUEST FOR PROPOSALS FOR DEVELOPMENT / REPOSITIONING /CONSTRUCTION / REAL ESTATE

The scope of required services includes, but is not limited to:

- 1. Development/ Repositioning/Construction/Real Estate: MHA is seeking counsel who is familiar with HUD repositioning strategies as well as HUD and other affordable housing financing programs; residential and commercial leases, licenses, titles, easements, eminent domain, local and state codes. Additionally, MHA requires prior experience representing MHA as an owner in redevelopment, repositioning and financing projects, including specifically Section 18 demolition/disposition applications and having familiarity with Federal and Connecticut contract law, advice and representation, in the various phases of application, pre-construction, design construction, lease up and project administration.
- 2. Contract Law: MHA enters into contracts for services which include, but not limited to, the procurement of supplies, services, professional services and construction. MHA may require legal counseling in the negotiation, construction, legal review of bids or proposals and supporting documentation or administration of these contracts. This includes providing contract interpretation and representing the Authority in bid and construction disputes and commercial claims.
- 3. Public Sector Law/Federal Housing Law: MHA operates utilizing subsidies from the Department of Housing & Urban Development. Accordingly, MHA seeks firms with an expertise in representing Authorities concerning its general obligations to the Department of Housing and Urban Development.
- 4. Affordable Housing Law: MHA is seeking counsel who is experienced in the field of affordable housing management and development including project based vouchers.
- 5. Administrative Law: MHA needs qualified attorneys in the administrative law field. An applicant's expertise should include enforcement powers of agencies, ethics, Freedom of Information Act, administrative rules, and the scope of federal, state and municipal agency powers.

Many of the issues encountered by MHA on a daily basis are technical in nature and subject to HUD or other regulatory body regulations. Therefore, MHA management and, in some instances, the Board of Commissioners, requires consultation and legal guidance in the application of these regulations and the creation of policy (Board) and procedures (MHA Management). Legal counsel will attend regular and special meetings of the Board of Commissioners and committees and any related entity boards and will be expected to be fluent in Robert's Rules and federal and state Freedom of Information Acts as they relate to meeting procedures and document availability.

The qualifications MHA is seeking include the following:

- 1. Must have demonstrated experience and extensive knowledge as to public and affordable housing and development and repositioning issues including specifically Section 18 demolition / disposition as well as regulatory compliance and guidance including the governing Connecticut State Statutes and HUD regulations. Please include a summary of previous work in the public/affordable housing industry;
- Must be admitted to practice and have demonstrated experience appearing before Connecticut and federal state and appellate courts, federal and state regulatory agencies and municipal boards and commissions;
- 3. Demonstrated capacity to prioritize MHA work, respond promptly to all inquiries and to competently and efficiently manage daily operational needs and development activities of MHA for the duration of the retention including potential renewals, including a description of current practice and current and anticipated obligations to other housing authorities, developers and affordable housing entities;

4.	Demonstrated client centered approach that appropriately staffs every assignment with a knowledgeable and team which understands the mission of the organization and determines and pursues the agency's specific goals in every matter, prioritizes responsiveness and efficiency and that takes into account value provided in relation to expense.
5.	Must provide annual proof of professional liability

DEADLINE FOR WRITTEN QUESTIONS

Written questions must be received by the MHA no later than 10:00am on October 17, 2025. Questions must be submitted to josephd@wmanchesterha.org. or stepheni@manchesterha.org.

In order to maintain a fair and impartial competitive process, the MHA will answer inquiries only in response to written questions received within the specific time frame. The MHA must avoid private communication with prospective respondents. Written questions will be the only opportunity for respondents to inquire as to form and content. Please respect this policy and do not attempt to query MHA personnel or members of its Board of Commissioners regarding this RFP. The only queries that will be acknowledged are those written questions submitted in the manner and within the time frame indicated above.

TIME OF PERFORMANCE

The services of this contract shall commence upon its execution and may be terminated by the MHA for its convenience at any point with ten (10) days written notice.

QUALIFICATIONS

Bidders must have membership in the Bar of the State of Connecticut and have appropriate experience in the provision of legal services on which they are bidding.

NON-DISCRIMINATION

The Respondent must not discriminate against any employee or applicant for employment because of race, color, religion, sex, age, or national origin. The Respondent shall take affirmative action to ensure that applicants are employed, and employees are treated during employment, without regard to race, color, religion, sex, age, or national origin. Such action shall include, but not be limited to, the following: employment, upgrading, demotion or transfer, recruitment, or recruitment advertising, layoff or termination, rates of pay or other means of compensation, and selection for training, including apprenticeship.

CONFLICTS OF INTEREST

The respondent will be required to certify that to the best of his/her knowledge and belief and, except as otherwise disclosed, s/he does not have any organizational conflict of interest. Conflict of interest is defined as a situation in which the nature of work under this contract and the respondent's organizational, financial, contractual, or other interests are such that:

- 1. Award of the contract may result in an unfair competitive advantage; or
- 2. The respondent's objectivity in performing the contracted work may be impaired. In the event the respondent has an organizational conflict of interest as defined herein, the respondent shall disclose such conflict of interest fully in the proposal submission.
- 3. The respondent agrees that, if after the award, s/he discovers an organizational conflict of interest with respect to this contract; s/he shall make an immediate and full disclosure in writing to the MHA's Executive Director. The disclosure shall include a description of the action that the respondent has taken or intends to take to eliminate or neutralize the conflict. The MHA may, however, terminate the contract if it is in the MHA's best interest and no other acceptable solution is possible.
- 4. In the event the respondent was aware of an organizational conflict of interest before the award of the contract and intentionally failed to disclose the conflict to the Executive Director, the MHA may terminate the contract.

- 5. No member or delegate to the U.S. Congress or the MHA Board of Commissioners shall be allowed to share in any part of this contract or to derive any benefit to arise there from. This provision shall be construed to extend to this contract if made with a corporation for its general benefit.
- 6. No member, officer, or employee of the MHA, no member of the Board of Directors for the Town of Manchester, and no other public official of such locality or localities who exercises any function or responsibilities with respect to the project shall, during his/her tenure, or for one (1) year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.
- 7. The MHA reserves sole and total discretion in determining the proper treatment of any conflict of interest disclosed under this provision.

NON-ASSIGNMENT

The Respondent shall not assign or transfer any interest in this Contract except that claims for monies due or to become due from the MHA under the Contract may be assigned to a bank, trust company, or other financial institution. If the Respondent is a partnership, this Contract shall inure to the benefit of the surviving or remaining member(s) of such partnership.

PROPOSAL SUBMISSION and DEADLINE

Proposals must be received no later than 2:00 PM Friday November 7, 2025 at the Housing Authority of the Town of Manchester, 24 Bluefield Drive, Manchester, CT. 06040.

Proposals must be submitted in a sealed envelope or box marked "General Counsel Legal Services Proposal". Submittals received after the deadline will not be considered.

No proposal shall be withdrawn for a period of ninety (90) days subsequent to opening without the consent of the MHA.

Proposals shall include the following:

1. Timetable

- Introductory works Please indicate when you would be able to start the engagement and begin to familiarize yourself with the MHA. State estimated hours required.
- Transition/Start-up Describe the transition process and the time necessary to complete

2. Background, Experience and Approach

- An executive summary of the proposal, including a statement of the firm's understanding of the services provided
- A brief narrative describing the firm or individual's location; legal background and history, including years of legal experience, number of partners, associates, staff; work experience associated with private or public low-income housing; legal experience related the Scope of Service and the rating factors; and the firm or individual's ability to provide legal services to the MHA.
- A list of at least three (3) current clients for whom services of a similar nature have been performed. For each client, please include a brief description of its organization and complexity and provide a point of contact and telephone number.
- Certified statement that the firm or individual is in good standing
- A non-collusive affidavit
- Documented evidence that the firm or individual is licensed to practice and is registered in Connecticut.
- Proposed hourly fee and service fees for work to be performed. For Special Counsel, if the proposal includes a fee which is other hourly, please detail how the fee will be calculated for all types of Housing Matters and Rent Collection Matters that are anticipated.

3. Staff Capability

- Provide information clearly demonstrating your capability to perform legal and other services as stated in the Scope of Services for each area of service for which the Respondent is seeking selection. This information should include resumes of the team of partners, managers, and associates who would be assigned to the MHA and any other information relevant to your qualifications to perform these services for the MHA.
- Steps taken at your firm to ensure continuity in the assignment of key staff from year-to-year.
- Commitments you will make regarding the team's accessibility to the MHA.
- A description of your firm's approach to providing legal services to the MHA.

4. Hours and Professional Fees

Your description of fees should include whatever schedules are necessary to adequately support and/or explain the proposed pricing. The basis for the fees should be stated (i.e., number of staff, level of staff, hourly rates, etc.). Please include a description of expected billing arrangements.

5. Summation

Please conclude with a statement about how your firm differs from other firms offering similar services. Address how the MHA will benefit from the services provided by your firm.

EVALUATION PROCESS AND SELECTION CRITERIA

Proposals will be evaluated by an MHA selection committee. The committee will present its recommendation to the MHA Board of Commissioners who will make the final selection.

Proposals will be evaluated using the Evaluation Criteria outlined below. After the initial scoring of proposals, those deemed by the selection committee to be within the competitive range will become the finalists and may be asked to appear for an interview to clarify issues and, if necessary, following the interview, to submit their best and final offers.

Proposals for each area of service will be compared to others in the same category when it comes to specific area of service proposed. A Respondent must receive at 50 points under the General Category to be evaluated under the Specific Category.

The Authority reserves the right to make an award without further discussion of the proposals submitted or to not conduct an interview process. Therefore, the proposals should be clear and complete regarding the above criteria.

COSTS INCURRED IN PREPARING AND SUBMITTING PROPOSALS

The respondent shall be solely responsible for all costs incurred in preparing and submitting a response to this RFP. All material and documents submitted by the respondent will become the property of the MHA and will not be returned. Legal firms selected for further negotiations, as well as the firm ultimately selected to enter into a contractual agreement with the MHA, will be solely responsible for all costs incurred during negotiations.

CONTRACT/AWARD

The contract for legal services as requested in this RFP will be subject to the approval of the MHA's Board of Commissioners.

The RFP will result in a fixed fee contract, the terms of which will be negotiated between the MHA and the selected respondent. The contract shall commence on the date specified therein and shall terminate upon completion of all services required pursuant to the contract unless terminated as provided therein. The base term of the contract shall not exceed five (5) years.

Start Date January 1, 2026 - End Date December 31, 2030

LIMITATION

This Request for Proposals does not commit the MHA to award a contract or to pay any cost incurred in the preparation and submittal of a proposal to this request. The Authority reserves the right to accept or reject any or all proposals, to negotiate with all qualified sources, or to cancel in part or in its entirety, the Request for Proposals, and to waive any informality regarding the proposals received whenever such acceptance, rejection, negotiation, cancellation, or waiver is in the best interest of the MHA.

ADDENDA

Any Addenda issued to provide additional information, responses to questions or other changes in the RFP, must be including with the submission as a signed copy acknowledging the addenda. Any response will be assumed to have been prepared with full knowledge of the content of any addenda issued by the MHA.

1. Preparation of Offers

- (a) Offerors are expected to examine the statement of work, the proposed contract terms and conditions, and all instructions. Fallure to do so will be at the offeror's risk.
- (b) Each offeror shall furnish the information required by the solicitation. The offeror shall sign the offer and print or type its name on the cover sheet and each continuation sheet on which it makes an entry. Erasures or other changes must be initialed by the person signing the offer. Offers signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the HA.
- (c) Offers for services other than those specified will not be considered.

2. Submission of Offers

- (a) Offers and modifications thereof shall be submitted in sealed envelopes or packages (1) addressed to the office specified in the solicitation, and (2) showing the time specified for receipt, the solicitation number, and the name and address of the offeror.
- (b) Telegraphic offers will not be considered unless authorized by the solicitation; however, offers may be modified by written or telegraphic notice.
- (c) Facsimile offers, modifications or withdrawals will not be considered unless authorized by the solicitation.

3. Amendments to Solicitations

- (a) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.
- (b) Offerors shall acknowledge receipt of any amendments to this solicitation by
 - (1) signing and returning the amendment;
 - (2) identifying the amendment number and date in the space provided for this purpose on the form for submitting an offer,
 - (3) letter or telegram, or
 - (4) facsimile, if facsimile offers are authorized in the solicitation. The HA/HUD must receive the acknowledgment by the time specified for receipt of offers.

4. Explanation to Prospective Offerors

Any prospective offeror desiring an explanation or interpretation of the solicitation, statement of work, etc., must request it in writing soon enough to allow a reply to reach all prospective offerors before the submission of their offers. Oral explanations or instructions given before the award of the contract will not be binding. Any information given to a prospective offeror concerning a solicitation will be furnished promptly to all other prospective offerors as an amendment of the solicitation, if that information is necessary in submitting offers or if the lack of it would be prejudicial to any other prospective offerors.

5. Responsibility of Prospective Contractor

- (a) The HA shall award a contract only to a responsible prospective contractor who is able to perform successfully under the terms and conditions of the proposed contract. To be determined responsible, a prospective contractor must -
 - Have adequate financial resources to perform the contract, or the ability to obtain them;

- (2) Have a satisfactory performance record;
- (3) Have a satisfactory record of integrity and business ethics;
- (4) Have a satisfactory record of compliance with public policy (e.g., Equal Employment Opportunity); and
- (5) Not have been suspended, debarred, or otherwise determined to be ineligible for award of contracts by the Department of Housing and Urban Development or any other agency of the U.S. Government. Current lists of ineligible contractors are available for inspection at the HA/HUD.
- (b) Before an offer is considered for award, the offeror may be requested by the HA to submit a statement or other documentation regarding any of the foregoing requirements. Failure by the offeror to provide such additional information may render the offeror ineligible for award.

6. Late Submissions, Modifications, and Withdrawal of Offers

- (a) Any offer received at the place designated in the solicitation after the exact time specified for receipt will not be considered unless it is received before award is made and it -
 - (1) Was sent by registered or certified mail not later than the fifth calendar day before the date specified for receipt of offers (e.g., an offer submitted in response to a solicitation requiring receipt of offers by the 20th of the month must have been mailed by the 15th);
 - (2) Was sent by mail, or if authorized by the solicitation, was sent by telegram or via facsimile, and it is determined by the HA/ HUD that the late receipt was due solely to mishandling by the HA/HUD after receipt at the HA;
 - (3) Was sent by U.S. Postal Service Express Mail Next Day Service - Post Office to Addressee, not later than 5:00 p.m. at the place of mailing two working days prior to the date specified for receipt of proposals. The term "working days" excludes weekends and U.S. Federal holidays; or
 - (4) is the only offer received.
- (b) Any modification of an offer, except a modification resulting from the HA's request for "best and final" offer (if this solicitation is a request for proposals), is subject to the same conditions as in subparagraphs (a)(1), (2), and (3) of this provision.
- (c) A modification resulting from the HA's request for "best and final" offer received after the time and date specified in the request will not be considered unless received before award and the late receipt is due solely to mishandling by the HA after receipt at the HA.
- (d) The only acceptable evidence to establish the date of mailing of a late offer, modification, or withdrawal sent either by registered or certified mail is the U.S. or Canadian Postal Service postmark both on the envelope or wrapper and on the original receipt from the U.S. or Canadian Postal Service. Both postmarks must show a legible date or the offer, modification, or withdrawal shall be processed as if mailed late. "Postmark" means a printed, stamped, or otherwise placed impression (exclusive of a postage meter machine impression) that is readily identifiable without further action as having been supplied and affixed by employees of the U.S. or Canadian Postal Service on the date of mailing. Therefore, offerors should request the postal clerk to place a hand cancellation bull's-eye postmark on both the receipt and the envelope or wrapper.

"Postmark" has the same meaning as defined in paragraph (c) of this provision, excluding postmarks of the Canadian Postal Service. - (c) "Contractor" means the person or other entity entering into the contract with the Authority to perform all of the work required under the contract.
- (d) "Day" means calendar days, unless otherwise stated.
- (e) "HUD" means the Secretary of Housing and Urban development, his delegates, successors, and assigns, and the officers and employees of the United States Department of Housing and Urban Development acting for and on behalf of the Secretary.

2. Changes

- (a) The HA may at any time, by written order, and without notice to the sureties, if any, make changes within the general scope of this contract in the services to be performed or supplies to be delivered.
- (b) If any such change causes an increase or decrease in the hourly rate, the not-to-exceed amount of the contract, or the time required for performance of any part of the work under this contract, whether or not changed by the order, or otherwise affects the conditions of this contract, the HA shall make an equitable adjustment in the not-to-exceed amount, the hourly rate, the delivery schedule, or other affected terms, and shall modify the contract accordingly.
- (c) The Contractor must assert its right to an equitable adjustment under this clause within 30 days from the date of receipt of the written order. However, if the HA decides that the facts justify it, the HA may receive and act upon a

proposal submitted before final payment of the contract.

- (d) Failure to agree to any adjustment shall be a dispute under clause Disputes, herein. However, nothing in this clause shall excuse the Contractor from proceeding with the contract as changed.
- (e) No services for which an additional cost or fee will be charged by the Contractor shall be furnished without the prior written consent of the HA.

3. Termination for Convenience and Default

- (a) The HA may terminate this contract in whole, or from time to time in part, for the HA's convenience or the failure of the Contractor to fulfill the contract obligations (default). The HA shall terminate by delivering to the Contractor a written Notice of Termination specifying the nature, extent, and effective date of the termination. Upon receipt of the notice, the Contractor shall: (i) immediately discontinue all services affected (unless the notice directs otherwise); and (ii) deliver to the HA all information, reports, papers, and other materials accumulated or generated in performing this contract, whether completed or in process.
- (b) If the termination is for the convenience of the HA, the HA shall be liable only for payment for services rendered before the effective date of the termination.

7. Disputes

- (a) All disputes arising under or relating to this contract, except for disputes arising under clauses contained in Section 111, Labor Standards Provisions, including any claims for damages for the alleged breach there of which are not disposed of by agreement, shall be resolved under this clause.
- (b) All claims by the Contractor shall be made in writing and submitted to the HA. A claim by the HA against the Contractor shall be subject to a written decision by the HA.
- (c) The HA shall, with reasonable promptness, but in no event in no more than 60 days, render a decision concerning any claim hereunder. Unless the Contractor, within 30 days after receipt of the HA's decision, shall notify the HA in writing that it takes exception to such decision, the decision shall be final and conclusive.
- (d) Provided the Contractor has (i) given the notice within the time stated in paragraph (c) above, and (ii) excepted its claim relating to such decision from the final release, and (iii) brought suit against the HA not later than one year after receipt of final payment, or if final payment has not been made, not later than one year after the Contractor has had a reasonable time to respond to a written request by the HA that it submit a final voucher and release, whichever is earlier, then the HA's decision shall not be final or conclusive, but the dispute shall be determined on the merits by a court of competent jurisdiction.
- (e) The Contractor shall proceed diligently with performance of this contract, pending final resolution of any request for relief, claim, appeal, or action arising under the contract, and comply with any decision of the HA.

8. Contract Termination; Debarment

A breach of these Contract clauses may be grounds for termination of the Contract and for debarment or denial of participation in HUD programs as a Contractor and a subcontractor as provided in 24 CFR Part 24.

9. Assignment of Contract

The Contractor shall not assign or transfer any interest in this contract; except that claims for monies due or to become due from the HA under the contract may be assigned to a bank, trust company, or other financial institution. If the Contractor is a partnership, this contract shall inure to the benefit of the surviving or remaining member(s) of such partnership approved by the HA.

10. Certificate and Release

Prior to final payment under this contract, or prior to settlement upon termination of this contract, and as a condition precedent thereto, the Contractor shall execute and deliver to the HA a certificate and release, in a form acceptable to the HA, of all claims against the HA by the Contractor under and by virtue of this contract, other than such claims, if any, as may be specifically excepted by the Contractor in stated amounts set forth therein.

11. Organizational Conflicts of Interest

- (a) The Contractor warrants that to the best of its knowledge and belief and except as otherwise disclosed, it does not have any organizational conflict of interest which is defined as a situation in which the nature of work under this contract and a contractor's organizational, financial, contractual or other interests are such that;
 - Award of the contract may result in an unfair competitive advantage; or
 - () The Contractor's objectivity in performing the contract work may be impaired.
- (b) The Contractor agrees that if after award it discovers an organizational conflict of interest with respect to this contract or any task/delivery order under the contract, he or she shall make an immediate and full disclosure in writing to the Contracting Officer which shall include a description of the action which the Contractor has taken or intends to take to eliminate or neutralize the conflict. The HA may, however, terminate the contract or task/delivery order for the convenience of the HA if it would be in the best interest of the HA.
- (c) In the event the Contractor was aware of an organizational conflict of interest before the award of this contract and intentionally did not disclose the conflict to the Contracting Officer, the HA may terminate the contract for default.
- (d) The terms of this clause shall be included in all subcontracts and consulting agreements wherein the work to be performed is similar to the service provided by the prime Contractor. The Contractor shall include in such subcontracts and consulting agreements any necessary provisions to eliminate or neutralize conflicts of interest.

12. Inspection and Acceptance

(a) The HA has the right to review, require correction, if necessary, and accept the work products produced by the Contractor. Such review(s) shall be carried out within 30 days so as to not impede the work of the Contractor. Any product of work shall be deemed accepted as submitted if the HA does not issue written comments and/or required corrections within 30 days from the date of receipt of such product from the Contractor.

(b) The Contractor shall make any required corrections promptly at no additional charge and return a revised copy of the product to the HA within 7 days of notification or a

later date if extended by the HA.

(c) Failure by the Contractor to proceed with reasonable promptness to make necessary corrections shall be a default. If the Contractor's submission of corrected work remains unacceptable, the HA may terminate this contract (or the task order involved) or reduce the contract price or cost to reflect the reduced value of services received.

13. Interest of Members of Congress

No member of or delegate to the Congress of the United States of America or Resident Commissioner shall be admitted to any share or part of this contract or to any benefit to arise there from, but this provision shall not be construed to extend to this contract if made with a corporation for its general benefit.

14. Interest of Members, Officers, or Employees and Former Members, Officers, or Employees

No member, officer, or employee of the HA, no member of the governing body of the locality in which the project is situated, no member of the governing body in which the HA was activated, and no other pubic official of such locality or localities who exercises any functions or responsibilities with respect to the project, shall, during his or her tenure, or for one year thereafter, have any interest, direct or indirect, in this contract or the proceeds thereof.

15. Limitation on Payments to Influence Certain Federal Transactions

(a) Definitions. As used in this clause:

"Agency", as defined in 5 U.S.C. 552(f), includes Federal executive departments and agencies as well as independent regulatory commissions and Government corporations, as defined in 31 U.S.C. 9101(1).

"Covered Federal Action" means any of the following Federal actions:

(i) The awarding of any Federal contract;

(ii) The making of any Federal grant;

(iii) The making of any Federal loan;

- (iv) The entering into of any cooperative agreement; and,
- (v) The extension, continuation, renewal, amendment, or modification of any Federal contract, grant, loan, or cooperative agreement.

"Indian tribe" and "tribal organization" have the meaning provided in section 4 of the Indian Self-Determination and Education Assistance Act (25 U.S.C. 450B). Alaskan Natives are included under the definitions of Indian tribes in that Act.

"Recipient" includes all contractors, subcontractors at any tier, and subgrantees at any tier of the recipient of funds received in connection with a Federal contract, grant, loan, or cooperative agreement. The term excludes an Indian tribe, tribal organization, or any other Indian organization with respect to expenditures specifically permitted by other Federal law.

"Regularly employed means, with respect to an officer or employee of a person requesting or receiving a Federal contract, grant, loan, or cooperative agreement, an officer or employee who is employed by such person for at least 130 working days within one year immediately preceding the date of the submission that initiates agency consideration of such person for receipt of such contract, grant, loan, or cooperative agreement.  - (d) The following agency and legislative liaison activities are permitted where they are prior to formal solicitation of any covered Federal action:
 - (1) Providing any information not specifically requested but necessary for an agency to make an informed decision about initiation of a covered Federal action;
 - (2) Technical discussions regarding the preparation of an unsolicited proposal prior to its official submission; and
 - (3) Capability presentations by persons seeking awards from an agency pursuant to the provisions of the Small Business Act, as amended by Public Law 95-507 and other subsequent amendments.
 - (e) Only those activities expressly authorized by subdivision (b)(ii)(1)(a) of this clause are permitted under this clause.
- (2) Professional and technical services.
 - (a) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply in the case of-
 - (i) A payment of reasonable compensation made to an officer or employee of a person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action, if payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action.
 - (i) Any reasonable payment to a person, other than an officer or employee of a

- person requesting or receiving a covered Federal action or an extension, continuation, renewal, amendment, or modification of a covered Federal action if the payment is for professional or technical services rendered directly in the preparation, submission, or negotiation of any bid, proposal, or application for that Federal action or for meeting requirements imposed by or pursuant to law as a condition for receiving that Federal action, Persons other than officers or employees of a person requesting or receiving a covered Federal action include consultants and trade associations.
- (b) For purposes of subdivision (b)(ii)(2)(a) of clause, "professional and technical services" shall be limited to advice and analysis directly applying any professional or technical discipline.
- (c) Requirements imposed by or pursuant to law as a condition for receiving a covered Federal award include those required by law or regulation, or reasonably expected to be required by law or regulation, and any other requirements in the actual award documents.
- (d) Only those services expressly authorized by subdivisions (b)(ii)(2)(a)(i) and (ii) of this section are permitted under this clause.
- (iii) Selling activities by independent sales representatives.
- (c) The prohibition on the use of appropriated funds, in subparagraph (b)(i) of this clause, does not apply to the following selling activities before an agency by independent sales representatives, provided such activities are prior to formal solicitation by an agency and are specifically limited to the merits of the matter:
 - Discussing with an agency (including individual demonstration) the qualities and characteristics of the person's products or services, conditions or terms of sale, and service capabilities; and
 - (ii) Technical discussions and other activities regarding the application or adaptation of the person's products or services for an agency's use.
- (d) Agreement. In accepting any contract, grant, cooperative agreement, or loan resulting from this solicitation, the person submitting the offer agrees not to make any payment prohibited by this clause.
- (e) Penalties. Any person who makes an expenditure prohibited under paragraph (b) of this clause shall be subject to civil penalties as provided for by 31 U.S.C. 1352. An imposition of a civil penalty does not prevent the Government from seeking any other remedy that may be applicable.
- (f) Cost Allowability. Nothing in this clause is to be interpreted to make allowable or reasonable any costs which would be unallowable or unreasonable in accordance with Part 31 of the Federal Acquisition Regulation (FAR), or OMB Circulars dealing with cost allowability for recipients of assistance agreements. Conversely, costs made specifically unallowable by the requirements in this clause will not be made allowable under any of the provisions of FAR Part 31 or the relevant OMB Circulars.

16. Equal Employment Opportunity

During the performance of this contract, the Contractor/Seller agrees as follows:

(h) The [contractor/seller] will include the provisions of paragraphs (a) through (h) in every subcontract or purchase order unless exe mpted by rules, regulations, or orders of the Secretary of Labor issued pursuant to section 204 of Executive Order 11246 of September 24, 1965, so that such provisions will be binding upon each sub[contractor/seller] or vendor. The [contractor/seller] will take such action with respect to any subcontract or purchase order as may be directed by the Secretary of Labor as a means of enforcing such provisions including sanctions for noncompliance: Provided, however, that in the event the [contractor/seller] becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the [contractor/ seller] may request the United States to enter into such litigation to protect the interests of the United States.

17. Equal Opportunity for Workers with Disabilities

3.In the event of the [contractor/seller] noncompliance with the requirements of this clause, actions for noncompliance may be taken in accordance with the rules, regulations, and relevant orders of the Secretary of Labor issued pursuant to the act.

4.The [contractor/seller] agrees to post in conspicuous places, available to employees and applicants for employment, notices in a form to be prescribed by the Director, Office of Federal Contract Compliance Programs, provided by or through the contracting officer. Such notices shall state the rights of applicants and employees as well as the [contractor/seller] 's obligation under the law to take affirmative action to employ and advance in employment qualified employees and applicants with disabilities.

No information or material shall be disseminated or disclosed to the general public, the news media, or any person or organization without prior express written approval by the HA.

19. Contractor's Status

It is understood that the Contractor is an independent contractor and is not to be considered an employee of the HA, or assume any right, privilege or duties of an employee, and shall save harmless the HA and its employees from claims suits, actions and costs of every description resulting from the Contractor's activities on behalf of the HA in connection with this Agreement.

20. Other Contractors

HA may undertake or award other contracts for additional work at or near the site(s) of the work under this contract. The contractor shall fully cooperate with the other contractors and with HA and HUD employees and shall carefully adapt scheduling and performing the work under this contract to accommodate the additional work, heeding any direction that may be provided by the Contracting Officer. The contractor shall not commit or permit any act that will interfere with the performance of work by any other contractor or HA employee.

21. Liens

The Contractor is prohibited from placing a lien on HA's property. This prohibition shall apply to all subcontractors.

22. Training and Employment Opportunities for Residents in the Project Area (Section 3, HUD Act of 1968; 24 CFR 135)

- (a) The work to be performed under this contract is subject to the requirements of section 3 of the Housing and Urban Development Act of 1968, as amended, 12 U.S.C. 1701u (section 3).
